

## INSTRUCTIONS FOR THE PRESENTATION OF FULL ABSTRACT TO BE AWARDED

Two prizes will be awarded to the best short papers submitted.

The evaluation will be held by a jury formed by specialist virologists appointed by the Organizing Committee of CAV 2021. The Jury will evaluate the originality, scientific methodology, rigor in the evaluation of results, and the presentation of the manuscript. Short papers will be evaluated anonymously.

Language: Spanish. Short papers in English will be also accepted for non-Spanish speaking foreign authors.

The short paper, including the abstract, must be submitted to the Scientific Committee using the form at the following link: <a href="https://forms.gle/eycLnraMzeXiT8ZB8">https://forms.gle/eycLnraMzeXiT8ZB8</a>

The paper must also be uploaded as an abstract for presentation at the Congress according to the abstract submission rules available on the web site (http://cav2020.viroarg.com/).

## Organization of the short paper

The first page will include:

Title, which should be brief and precise (15 words or 120 characters) and should give a clear indication of the topic.

Name and surname of the AUTHORS. Immediately after the title, separated by semicolons, the surname and initials of the authors' names should be indicated, separated by commas, as follows: López X., Pérez C., Zulanta I., and Benavente R.

The e-mail address of each of the authors; as well as the complete data (postal address, telephone and e-mail) of the reference author where to send the correspondence.

The institution(s) where the study was conducted.

The funding received, if applicable.

Abstract of up to 2000 characters (including spaces).



The manuscript should not mention the full names or initials of the authors or the institution where the study was carried out. Likewise, any identification of the person/s (e.g. names, initials) should be avoided in the illustrations as well as in the manuscript.

The text should be up to 10 (ten) A4 size pages (21 x 29 cm), including abstract, tables, figures and bibliography, including abstract, tables, figures and bibliography; typed with 1.5 line spacing and minimum font size 12.

The organization of the short paper will be in accordance with: Title,Introduction, Materials and Methods, Results, Discussion and conclusions, Bibliography

Manuscripts will not be accepted if:

- do not arrive electronically.
- they are isolated case reports.
- it has been accepted for publication or published at the date of submission.
- do not respect the format indications suggested in these regulations.

Failure to comply with them will be grounds for exclusion and the work will not be considered for evaluation.

Two copies of the paper should be sent, one containing the name and affiliation of the authors on page 1 and the second copy should not contain this information. The second copy will be sent to the jurors for evaluation.

THE PAPER MUST HAVE THE ENDORSEMENT OF ALL THE AUTHORS, who will be informed of its receipt by e-mail.
